All parties desiring trades must contact central entry during call back or arena secretaries on days of a rodeo to initiate and verify trades. c. Verification of trades by all involved parties with central entry or arena secretaries must be by telephone, cell phone, or in writing signed by all involved parties.</p>

NO Children under 18 All dogs must be on a leash, except for stock contractor or special acts absolutely no dogs in grandstands</p>
